As a news agency and research center that has provided in-depth coverage of the Palestine Liberation Organization, the Palestinian Authority and UNRWA since 1987, it has come to the attention of our office that the school year for UNRWA in Judea, Samaria, Gaza and Jerusalem commences at the end of August.

Since UN schools are universally committed to the sacrosanct principle of "Peace Starts Here", UNRWA spokesperson Tamara Al-Rifai has been asked as to whether the UNRWA school system will this year be adjusted so that anti-Semitic and war-like language would be excised from the curriculum.

The question was posed to UNRWA, in the context of the July 14th anti-incitement memo signed by UNRWA and the U.S., which commits UNRWA to conduct an educational curriculum that would now be devoid of incitement.

The UNRWA spokesperson answered very honestly, that UNRWA has no curriculum on its own and that it depends on the textbooks provided by the host countries and that UNRWA would not interfere with the textbooks taught by the Palestinian Authority, which is viewed by UNRWA as a host country.

That means that the school year scheduled to begin would again use the curriculum of the PA.

1987'den bu yana Filistin Kurtuluş Örgütü, Filistin Yönetimi ve UNRWA'ya derinlemesine yer veren bir haber ajansı ve araştırma merkezi olarak, UNRWA okullarının Yahudiye, Samiriye, Gazze ve Kudüs de eğitim-öğretim yılının Ağustos sonunda başlayacağı, ofisimizin dikkatini çekmiştir.

BM okulları evrensel olarak "Barış Burada Başlar" şeklindeki kutsal ilkeye bağlı olduklarından, UNRWA sözcüsü Tamara Al-Rifai'ye, UNRWA okul sisteminde bu yıl, Yahudi aleyhtarı ve savaş benzeri içerikler dahil eden kitapların değiştirilip değiştirilemeyeceği ve müfredattan çıkıp çıkmayacağı soruldu.

Soru, UNRWA ve ABD tarafından imzalanan ve UNRWA'nın kışkırtıcı eğitim müfredatından vazgeçmesine taahhüt eden 14 Temmuz tarihli anlaşmadan sonra, UNRWA'ya yöneltildi.

UNRWA sözcüsü çok dürüstçe yanıtladı, UNRWA'nın kendi başına bir müfredatı olmadığını ve ev sahibi ülkeler tarafından sağlanan ders kitaplarına bağlı olduğunu ve UNRWA'nın ev sahibi olarak gördüğü Filistin Otoritesi tarafından verilen ders kitaplarına müdahale etmeyeceğini söyledi.

Bu, başlaması planlanan okul yılının tekrar PA müfredatını kullanacağı anlamına gelir.

Türkiye, UNRWA'ya bağış yapan önde gelen ülkelerden biri olarak, UNRWA'nın bu okul kitaplarını olduğu gibi özümseyeceği fikrini kabul etmek yerine, Birleşmiş Milletler'in barış ve uzlaşma değerlerini pek yansıtmayan bu ders kitaplarının yeni eğitim-öğretim yılında silinmesini talep edecek mi?

Como agencia de noticias y centro de investigación que ha proporcionado una cobertura en profundidad de la Organización de Liberación de Palestina, la Autoridad Palestina y la UNRWA desde 1987, ha llamado la atención de nuestra oficina que el año escolar de la UNRWA en Judea, Samaria, Gaza y Jerusalén comienza a finales de agosto.

Dado que las escuelas de la ONU están universalmente comprometidas con el principio sacrosanto de "La paz comienza aquí", se le preguntó a la portavoz de la UNRWA, Tamara Al-Rifai, si el sistema escolar de la UNRWA se ajustará este año para que el lenguaje antisemita sea extraído del plan de estudios.

La pregunta fue planteada a UNRWA, en el contexto del tratado del 14 de julio firmado por UNRWA y los Estados Unidos, que compromete a UNRWA a llevar a cabo un plan de estudios educativo que ahora estaría desprovisto de incitación.

El portavoz de UNRWA respondió muy honestamente, que UNRWA no tiene un plan de estudios por sí solo y que depende de los libros de texto proporcionados por los países anfitriones y que UNRWA no interferiría con los libros de texto enseñados por la Autoridad Palestina, que es considerada por UNRWA como un país anfitrión.

Eso significa que el año escolar programado para comenzar volvería a utilizar el plan de estudios de la AP.

Como una de las naciones líderes en hacer donaciones a UNRWA, ¿exigirá España la eliminación de estos libros de texto, que difícilmente reflejan los valores de paz y reconciliación de las Naciones Unidas, en lugar de aceptar la idea, de que UNRWA absorberá una vez más estos libros escolares como están, en el nuevo año académico?

Seine Exzellenz, sehr geehrter Herr Clages,

Als Nachrichtenagentur und Forschungszentrum, das seit 1987 eingehend über die Palästinensische Befreiungsorganisation, die Palästinensische Autonomiebehörde und die UNRWA berichtet, ist unser Büro darauf aufmerksam geworden, dass das Schuljahr der UNRWA in Judäa, Samaria, Gaza und Jerusalem Ende August beginnt.

Da UN-Schulen dem unantastbaren Prinzip „Frieden beginnt hier“ verpflichtet sind, wurde UNRWA-Sprecherin Tamara Al-Rifai gefragt, ob das UNRWA-Schulsystem in diesem Jahr so angepasst wird, dass antisemitische und kriegerische Sprache vom Lehrplan herausgenommen werden.

Die Frage wurde der UNRWA im Zusammenhang mit dem von der UNRWA und den USA unterzeichneten Vertrag vom 14. Juli gestellt, welches die UNRWA dazu verpflichtet, einen Lehrplan durchzuführen, der nun frei von Aufstachelung sein würde.

Die UNRWA-Sprecherin antwortete sehr ehrlich, dass die UNRWA keinen eigenen Lehrplan habe und dass dies von den Lehrbüchern der Gastländer abhängt und dass die UNRWA die Lehrbücher der Palästinensischen Behörde, die von der UNRWA als Gastgeberland betrachtet wird, nicht stören würde.

Dies bedeutet, dass das zu Beginn des Schuljahres geplante Schuljahr wieder den Lehrplan der PA verwenden würde.

Wird Deutschland als eine der führenden Nationen, die an die UNRWA spenden, die Streichung dieser Lehrbücher fordern, die kaum die Werte der Vereinten Nationen von Frieden und Versöhnung widerspiegeln, statt die Idee zu akzeptieren, dass die UNRWA diese Schulbücher im neuen Schuljahr wieder so aufnehmen wird?
